Reference: Show cause notices served upon the firm vide letter Nos. PIE/ENGG/SIE/MAT/121 dated 2nd April 2021 and PIE/ENGG/SIE/MAT/133 dated 21st April 2021

1. That the Contract for Construction of Roads and other Services at Sundar Industrial Estate was awarded to the firm (M/S MAT Technologies) vide Contract No. PIE/SIE-EARP/16/21 on 28th October 2016, with a time limit upto 31st January 2017. On the request of firm time for completion was extended upto 15th January 2018 but the firm instead of commencing the work. left the site abandoned, hence the contract was terminated.
2. That, show cause notice was issued to the firm as per Rule 21 of PPR-2014 vide letter Nos. PIE/ENGG/SIE/MAT/121 dated 2nd April 2021. Response of the firm to the said show cause notice was not agreed to by the Authority and the firm was directed to appear through its authorized representative for personal hearing vide letter Nos. PIE/ENGG/SIE/MAT/133 dated 21st April, 2021, PIE/ENGG/SIE/MAT/139 dated 4th May 2021 and PIE/ENGG/SIE/MAT/168 dated 2nd July, 2021.
3. M/S MAT Technology during personal appearing before "The Engineer" on 6th July 2021, could not forward plausible reasons for non-commencement of the work.
4. Foregoing in view, M/S MAT Technologies having office address, House No. 15, Street No.6, Safari Villas 1, Bahria Town, Rawalpindi. is hereby blacklisted / debarred from participating directly or indirectly in any work / bidding process of PIEDMC with immediate effect, for a period of three (03) years .
