4. Applicant shall not be paid interest/markup on deposited amount.
5. Plots are transferable, however transfer of Allotted Plot shall be allowed after receipt of full payment
6. Transfer fee @ 4% of Plot Price will be charged at the current rate and subsequently approved by BOD, PIEDMC.
