Instructions

Please follow the instructions /conditions given below:

1. Your quotation should be sealed accompanied bid security of Rs. 74,758/- in shape of Bank Guarantee/Pay Order/ Demand Draft / CDR in Favor of PIEDMC from a scheduled Bank in Pakistan.
2. All procurement will be carried out as per PPRA rules 2014 (amended up to date) Single Stage One Envelope procedure and Purchase Order will be issued to the lowest evaluated responsive bidder.
3. Your bid must be valid for minimum 90 days from bid opening date.
4. Delivery Schedule should be attached with quotation and shall not more than Thirty (30) days from the date of issuance of work order by Project Director (BWPIE) as given at para-7.
5. The price should be inclusive of all taxes, G.S.T and other levies applicable under law of Pakistan.
6. In case of delay in completion of works against given/decided schedule 0.5% of final bid /day will be charged as liquidity damage and maximum up to 10% of Work Order amount.
7. Date of commencement will be the date of start of plantation which should be taken in hand subject to the suitability of weather for this purpose in consultation with local forest officer of Bahawalpur.

Evaluation

The evaluation will be carried out on Least Cost Method; and award of work will be made to the lowest evaluated responsive bidder; from among those bidders who have fulfilled the criteria mentioned below:

- a) The Bidder should be in business for not less than 3 years. Documentary evidence to be provided.
- b) The Bidder should be registered with the income tax department. Documentary evidence to be provided.
- c) The Bidder should be an active tax payer. Documentary evidence to be provided

Scope of Work

- i. Scope of work includes Supply, Plantation and Maintenance of Plants for Six Months. Dried out plants during maintenance period will have to be replaced free of cost by the supplier.

- ii. The successful bidder will have to furnish Performance Guarantee equal to 5% of the Contract amount in the form of Bank Guarantee / CDR from a scheduled Bank in Pakistan within 15 days of issuance of Acceptance Letter

Payments:

1. Payment shall be made to the supplier through cross cheque / Pay Order as per mode given below.
 - a) 70% on delivery of plants at site, against Payment invoice within 15 days of submission
 - b) 20% on Plantation.
 - c) 10% after completion of maintenance period of Six months.
2. Sealed financial bids shall be received in **Office of the Project Director, Bahawalpur Industrial Estate, Dera Masti, Near Total Petrol Pump, N-5, Bahawalpur** on or before **26th December, 2023**, by 1100 Hrs and will be opened on same day at 1130 Hrs in the presence of bidders or their representatives.
3. The work will be awarded on Least Cost Basis after the evaluation of Bids.
