## CONDITIONS FOR SALE OF VEHICLES

1. The bidding process will be in accordance with the prevailing PPRA Rules Punjab.
2. Tender Form to offer price of vehicles in sealed and signed cover / envelope marked “OFFER FOR SALE OF VEHICLE” is available at PIEDMC Head Office or can be downloaded from PIEDMC / PPRA website [www.pie.com.pk](http://www.pie.com.pk) / [www.ppra.org.pk](http://www.ppra.org.pk)
3. Earnest money Rs. 100,000 for each car in shape of Pay Order / Bank Draft against vehicles to be purchased, in favour of “Punjab Industrial Estates Development & Management Company (PIEDMC)” will have to be attached with the Tender Forms. Bids / Offers without earnest money will be rejected.
4. The successful bidder will have to lift the vehicle after depositing the balance amount within 10 working days of acceptance of bids. In the event of failure to do so the Earnest Money will be forfeited.
5. Bids in sealed envelope, marked on top of Envelope “OFFER FOR SALE OF VEHICLE” should be sent by Registered Post / Courier Service addressed to Chief Engineer (Planning & Contracts) or delivered personally at Head Office, Punjab Industrial Estates Development and Management Company, Sundar Industrial Estate Commercial Area North, Sundar – Raiwind Road Lahore. 14. The vehicle will be handed over to successful bidder after receiving 100% payment of bid (s) amount.
