Terms and Conditions

1. Mode of Payment
 - a. Payment will be made through cross cheque in the name of company as per following schedule
 - I. 90% on supply of goods
 - II. 10% after defect liability period of one year.
2. Tax Deduction : As per prevailing tax laws.
3. Completion Time : Within 20 calendar days after the date of issuance of Purchase Order.
4. The bid must be accompanied with Rs. 19,000/- (Rupees nineteen thousand Only), which is 4.5% of the estimated cost, as Bid Security in the form of Bank Guarantee/ CDR / Pay Order/Demand Draft from a scheduled Bank in Pakistan in favor of PIEDMC, which will be released on satisfactory supply of the goods by the successful vendor.
5. The Bid must be valid for at least 90 calendar days.

8. Evaluation will be carried out on Least Cost Method and award will be made to the lowest evaluated responsive bidder; from among those bidders who have fulfilled the criteria mentioned below.

- (a) The vendor should be an active tax payer. Documentary evidence to be provided
- (b) The vendor should be in business for not less than 5 years. Documentary evidence to be provided
- (c) Firm should be registered with the income tax department. Documentary evidence to be provided

- (d) Vendor should be Sales Tax registered. Documentary evidence to be provided
- (e) The vendors/suppliers/manufactures who otherwise found the lowest amongst bidder will be bound to show sample articles to the bid committee to monitor quality, specifications and design given in this document. Contract will be awarded subject to the satisfaction of the bid committee.

9. The quotations in prescribed manner should reach the undersigned by 1030 hrs, 15th March, 2022; and will be opened at 1100 hrs on the same day in the presence of bidders or their representatives who wish to remain present.
